SECURING APPOINTMENT DATE

Your appointment date(s) and service(s) will be secured when the signed contract and deposit have been received. All bookings for weddings are made on a "first-come-first served" basis. Wedding party minimum of five (5) people including the bride. An early morning fee of \$50 per stylist will be added for all appointments starting prior to 6:00 a.m. No dates will be guaranteed without a signed contract and deposit.

DEPOSIT

A non-refundable deposit of \$50.00 is required to reserve and book the wedding date. The reservation(s) will be cancelled if the payment and the signed contract are not received by the due date. Please make checks payable to Anna Costa.

PAYMENT INFORMATION

The above client commits to paying the stylist(s) the fees as discussed prior to the event date. These payments will compensate the stylist for travel fees as well as style services. The payment will be remitted to the stylist at the completion of the services. Prices are subject to change as styling needs change or services added. Cash and/or checks accepted.

CONTRACT AND APPOINTMENT CHANGES

All agreements will be made in writing. Any changes/additions to guests or wedding party members requesting additional services after the contract is signed must be submitted in writing (no changes will be made over the telephone). Charges for guest(s) requiring additional services must be paid in full on the day of the service.

PREPARATION

Please arrive for your appointment at least 15 minutes prior to your schedule time. Updo appointments should arrive with dry hair. A blow dry charge will be added to anyone needing extra service.

CANCELLATION

Cancellations and/or modifications to the contract may be made up until **two weeks** before the date of service. If beyond that time period, client agrees to pay the contracted amount in full regardless if the number of participants decreases by the amount originally contracted.

TRAVEL

There is a \$50.00 travel fee to all locations.
